Actions for Sustainability

The SUSTOUKA Project aims at improving the Sustainable Consumption and Production (SCP) performance of the Tourism Sector of Kazakhstan by:

- Equipping Micro, Small and Medium Enterprises (MSMEs) of the Tourist Accommodation Sector with the necessary knowledge and tools to embrace opportunities for green business development.
- Promoting green consumption and better informed public and private consumers by elaborating practical guides and developing awareness raising campaigns.
- Providing more efficient SCP policies in order to minimise environmental impacts of the Tourism Sector of Kazakhstan.
- Increasing access to green financing for the tourism MSMEs.

Implementation of SCP practices and Travelife


After providing training on SCP Practices and sustainability schemes to more than 100 MSMEs, SUSTOUKA project has started the implementation phase in which SCP Practices and Travelife will be implemented in 50 MSMEs of the Tourist Accommodation sector and 25 tour operators. Project partners will provide continuous support to MSMEs along the implementation process through technical assistance, monitoring visits, customised documents and personalised coaching.



Guide on SCP practices

SUSTOUKA consortium has developed the first version of the **Guide on SCP Practices for the Tourist Accommodation Sector of Kazakhstan.**





This guide provides an overview of a number of SCP Practices for the Tourists Accommodation Sector focused mainly on the three areas with higher impact on accommodations: energy, water and waste, including wastewater and hazardous waste. This practical guide will be of great help for the implementation of the most successful SCP practices so as to overcome the main hotspots that contribute to negative environmental, economic and social impacts. Practices are divided into three categories depending on the effort and investment required for their implementation. The guide also includes specific implementation and monitoring tips and procedures with the objective of helping accommodations from the beginning of the process.

Once the implementation of the SCP Practices in the 50 selected MSMEs in the Tourist Accommodations Sector has been completed, the guide will be enriched with practical information gained from the implementation process to further enhance its usefulness among MSMEs in the sector.

Survey for the design of an awareness raising campaign



Events organised by SUSTOUKA Project

Roundtable on Green Financing for the Tourism Sector

On 7 April 2022, an event entitled "Green Financing Schemes Addressed to Tourism Sector MSMEs" was carried out with the objective of promoting a dialogue on the opportunities of green financing initiatives.

Green Financing is an effective and necessary tool to promote SCP practices and sustainable certification systems among MSMEs. Adapting green financing schemes to their particular requirements and needs can encourage MSMEs to the uptake of sustainable solutions and move towards the sustainability of the Tourism Sector.

During this event, public and private national and international financial institutions shared information and knowledge with MSMEs from the Tourism Sector of Kazakhstan. Representatives of the major Green Financing institutions, such as the European Investment Bank (EIB), Astana International Financial Centre (AIFC) and the Green Economy Financing Facility (GEFF) among others, reviewed national and international current green financing options and available funding programmes.

In the second part of the event, a discussion session was held between green financing bodies and MSMEs with the aim of exchanging information and promoting incentives and opportunities for tourism MSMEs. This event set grounds for future business-to-business meetings between financial institutions and tourism MSMEs within the project.





KITF participation

SUSTOUKA Project, through its local partners KTA and KAGIR, took part in the Kazakhstan International Exhibition TOURISM AND TRAVEL (KITF), held from 20 to 22

April in Almaty with the objective of presenting the project and the main activities being developed in the country, as well as engaging discussions on cooperation for the facilitation of sustainable tourism development in Kazakhstan.

KITF is the main event of the Tourism Sector of Kazakhstan, while it is the largest professional tourism exhibition in Central-Asia. Tourism companies, organisations and industries from more than 60 countries participated this year in KITF's 20th anniversary.









Main results achieved by the Project until now

- More than 180 employees from MSMEs trained on sustainable hotel management, SCP practices and Travelife certification system.
- More than 480 participants in the project events, the majority of whom (59%) were women. The percentage of participants in the events with a high degree of satisfaction has exceeded 92%.
- Almost 40 dissemination materials and/or presentations accessible through our website with the objective of providing information to tourism MSMEs about sustainability, green financing or environmental regulation, among others.
